On page 4, part A:

for: **'Please note that you may apply for one of these competitions and only in one field. You must choose which one when you register online, and cannot change your choice after the closing date for registration.'**

On page 7, part A II, 3(b):

for: **'You must give details of your knowledge of languages in the electronic registration form ⁽²⁾ and in the application form. Your choice of languages for taking the tests may not be changed after the deadline for confirming registrations (see section D.1, NB).'**

read: **'You must give details of your knowledge of languages in the electronic registration form ⁽²⁾ and in the application form.'**

On page 15, part D. 1:

for:

'NB

Within one month following the final date for registration, EPSO will invite you to:

- *confirm your application,*
- *confirm your choice of languages,*
- *and, where applicable, to choose the city in which you wish to sit the admission test and (if applicable) the written tests.*

*The invitation and your confirmation will take place via your EPSO profile **only**.*

If you do not confirm your application within two months following the final date for registration, EPSO will consider that you have withdrawn your application and it will be terminated.'

(i) **'Computerised admission tests organised in specialised centres (CBT)**

Within a period of about one month dating from the deadline for registration, candidates will receive, via their EPSO profile, the information concerning the organisation of the admission tests.

(ii) **Admission tests on paper organised simultaneously for all candidates**

Within one month following the final date for registration, EPSO will invite you to:

- *confirm your application,*
- *confirm your choice of languages,*
- *and, where applicable, to choose the city in which you wish to sit the admission test and (if applicable) the written tests.*

*The invitation and your confirmation will take place via your EPSO profile **only**.*

If you do not confirm your application within two months following the final date for registration, EPSO will consider that you have withdrawn your application and it will be terminated.'
